CHILD ABUSE PREVENTION GRANT DRAW DOWN: Moved by Baier and seconded by Wedemeyer for Auditor Berg, as contract administrator, to sign the child abuse prevention grant draw down. Approved. Engineer Kauffman arrived at 9:04 a.m.

COUNTY HANDBOOK CHANGES DISCUSSION: Sheriff Vandewater talked about the sick time in the handbook adding similar language from FMLA for the Sheriff's Department since it is challenging because he has 24/7 staff. Twombly recognized that departments are different and should vary sometimes. No other discussion was on the handbook changes today and the Board will have it on next week's agenda moving forward. Recorder Schneider exited at 9:09 a.m.

SHERIFF: Sheriff Vehicle Funds – Sheriff Jeff Vandewater stated that Chevrolet is slow on getting manufactured vehicles together, 2 that the Sheriff's Dept have in this fiscal year may be in lowa but are not put together and ready to be purchased yet. This is out of Sheriff Vandewater's control and it is just the way it is. Twombly said there is an option to have a budget amendment later. Moved by Wedemeyer and seconded by Baier to move the funds for the two vehicles from the FY2023 budget to the FY2024 budget. Approved.

VA COMMISSIONER APPOINTMENT: Moved by Hoadley and seconded by Baier to appoint John Schildberg to the Veteran's Affairs Commisioner Board. Approved.

ENGINEER: Secondary Roads Benefit Policy – Moved by Hoadley and seconded by Baier to table this policy. Approved. Engineer Kauffman would like this to be put on next week's agenda. Sign Contract And Performance Bond – Moved by Baier and seconded by Hoadley to sign the contract and performance bond for W14 Jefferson bridge project L-LBRW14J-73-01 per Engineer Kauffman's recommendation. Approved. Maintenance & Activities Report – The bridge being worked on at Orient should be done next week and the guard rail should be on tomorrow. The County will be doing the dirt work and will start next week. June 22nd is the letting for a box culvert in Prussia. Murphy is doing the clean up and the guard rail is coming tomorrow at the Richland project and should be rocked next week. The paint markings contractor should be here Monday to start. July 17th the box culvert letting should start on Union project. July 18th will be the letting for box extensions south of Fontanelle. Hoadley asked when there will be work on Henry A. Wallace Road and that will be in Fiscal Year 2024.
