**SICOG HOUSING TRUST FUND REPORT:** Moved by Wedemeyer and seconded by Twombly to approve the Southern Iowa Council of Governments Housing Trust Fund Report for July through December.

ENGINEER: ROW & Temporary Easement Purchase Resolution: Moved by Twombly and seconded by Hoadley to approve Resolution #2023-12 - Right-Of-Way And Temporary Easement Purchase. Whereas, it is sometimes necessary for Adair County to obtain additional right-of-way and/or temporary easement in order to construct improvements to the Secondary Road system; And Whereas, there is a need to establish a level of compensation for such newly acquired right-of-way and/or temporary easement; And Whereas, recent sales of land within Adair County have been made at an average of 6.79 time the county assessor's valuation of the land; Be It Resolved, that Adair County hereby establishes the rate of 6.79 times the county assessor's valuation of the parcel to which the newly acquired right-of-way was a part and ALSO hereby establishes the rate of 6.79 times the county assessor's valuation of the parcel to which the temporary easement was a part of, with no payment for a single temporary easement equaling less than \$100.00. Roll Call Vote: Walker, aye; Twombly, aye; Wedemeyer, aye; Baier, aye: and Hoadley, aye. Approved. Compensation Of Fence Resolution: Moved by Baier and seconded by Hoadley to approve Resolution #2023-13 - Compensation For Fence. Whereas, it is sometimes necessary to remove fences to construct projects at locations where additional county road Right-Of-Way has been acquired; And Whereas, the landowners incur added expense for the replacement of this fence on the property outside of the newly acquired Right-Of-Way; And Whereas, Adair County will compensate the landowners from whom additional Right-Of-Way has been obtained at the rate of \$55.00 per rod for fence of any type that is removed due to the purchase of said new Right-Of-Way. In addition Adair County will compensate the landowners \$85.00 per cost for each additional cornerpost/bracepost combination needed to construct the new fence because of the changes in the fence alignment due to the new construction as determined by the proposed plans. Rolling Hills Road Use Agreement: Moved by Twombly and seconded by Baier to approve the Rolling Hills Road Use Agreement and Completion of Work. Approved. Report of Maintenance & Activities: Engineer Kauffman gave an update to the Board on the following projects: Fuel System was powered up, but gas pump isn't working so they are working on that now.
