The Department of Agriculture did not have any concerns and have already approved the project. Roberts stated that he also works with Madison County and they pay a flat rate of \$200/per call plus mileage. The last time this was discussed by the Board was back in 2012 where the Board had raised the fee from \$75 to \$150/per call, which they agreed would cover the mileage cost at that time. Berg stated that some other surrounding Counties, like Union and Adams Counties, are paying the same as Madison County and others are paying more. Moved by Wedemeyer and seconded by Hoadley to raise the medical examiner fee to \$200/call plus mileage beginning July 1, 2025. Approved.
