

Permit for Tile Crossing in Adair County (As Per Iowa Code 468.622)

1. Applicant must contact Iowa One Call for utility locations within the excavation area. Call 1-800-292-8989 at least 48 hours before starting work.
2. Before the permit is issued, petitioner must submit an accurate estimate of cost for review by the County Engineer. All requests must be made at least two weeks before construction. The permit expires 90 days after issuance.
3. Road crossings shall be done to minimize the disruption of traffic. No open trenches will be allowed overnight.
4. All roads must be bored. No open trench crossings will be allowed.
5. Tile crossings shall be made with corrugated metal pipe (CMP) and bolted splices, pipe with a tight slip-joint or any other tight joints as supplied by the County Engineer. Plastic or PVC pipe supplied by the contractor must be approved by the County Engineer. 48 hour advanced notice must be made with the Secondary Road Department to pick up materials (call 641-743-2356). The applicant will be responsible for delivery of the pipe. The pipe may be picked up at the Greenfield shop Mon-Thurs 7:00 AM – 3:00 PM excluding holidays. The approved permit must be presented to receive the pipe.
6. Drain tile crossings started or completed prior to receiving written permission from the County Engineer will not be considered for payment. No payment will be made for tile crossings carrying septic tank effluent or other sewage of any type.
7. Reimbursement requires original invoice and payment verification by contractor or cancelled check. The applicant will also need to complete a W-9 Tax Form furnished by the County. Reimbursement will be actual costs up to \$1500 for a bored crossing, or as allowed in the county budget.
8. Tile intakes will not be placed within the right-of-way.
9. All tile crossings are to be properly connected on both ends to existing or new field tile. No payment will be made, or pipe furnished, for tile crossings that are not connected to field tile on both sides of the road. Signatures from both landowners are required.
10. When performing work within the right-of-way, the Contractor/Permitee/Licensee agree that for all work done in the county right-of-way, easement or other county property, that they shall be solely responsible for work zone safety and shall hold the county harmless and agree to indemnify the county from all claims that arise from their work in the right-of-way, and further, they agree that they will adhere to the Manual on Uniform Traffic Control Devices (MUTCD) during the project. The Contractor/Permitee/Licensee is responsible for providing, installing, maintaining, and cleaning warning signs and protective devices; removing warning signs and protective devices when the work is complete; and providing flaggers for the protection of the traveling public and workers on the site.
